### ORDER:

In the Government Order first read above, among others, the Government accorded administrative sanction for the implementation of Tamil Nadu Urban Health Care Project components viz., Upgrading Tertiary Hospitals, Strengthening Referral and Secondary care Hospitals, Strengthening Hospital Management and Primary Health Care in Non-Communicable Diseases at a total cost of Rs.1634,69,50,000/- with the assistance of Japan International Co-operation Agency.

2. In Government order second read above, among others, the Government have formed the State Empowered Committee for the Tamil Nadu Urban Health Care Project under the Chairmanship of the Chief Secretary to Government. The financial powers of the State Empowered Committee shall be upto Rs.5.00 crore for civil works, equipment and for services.

3. In the letter third read above, the Project Director, Tamil Nadu Urban Health Care Project has stated that, the activity of provision of training on Non-Communicable Diseases namely Hypertension, Diabetes and Cancers, Road Traffic Accidents and Hospital Management and equipment maintenance to Medical Officers, Staff Nurse, Pharmacist, Lab Technicians and Ministerial Staff from project hospitals and Urban Primary Health Centres from project cities is included in the Component 4 under the heading "Strengthening Hospital Management" in the Detailed Project Report and Minutes of Discussion. Japan International

Co-operation Agency concurrence obtained for the training schedule on 24.11.2020. The following trainings are proposed to provide to Medical Officers, Staff Nurse, Pharmacist, Lab Technicians and Ministerial Staff from the project hospitals and Primary Health Centres from project cities as detailed below:-

He has added that, the cost involved in this proposal is reimbursable by Japan International Co-operation Agency except the taxes involved, the cost involved for advertisement and for Annual Maintenance Contract. The Advertisement cost and the taxes are to be met out by Government of Tamil Nadu as part of project cost. The Annual Maintenance Cost will be borne by the Government through the regular budget to the Directorate of Public Health and Preventive Medicine.

4. The Project Director, Tamil Nadu Urban Health Care Project has also stated that, the State Empowered Committee has approved the above proposal on 11.01.2021 and requested the Government to issue necessary orders in this regard.

5. The Government have examined the proposal of the Project Director, Tamil Nadu Urban Health Care Project in detail and accordingly, do and hereby issue the following orders:-

- i. The Project Director, Tamil Nadu Urban Healthcare Project is permitted to incur the amount of Rs.8,30,87,351/- (Rupees Eight crore thirty lakh eighty seven thousand three hundred and fifty one only) as non-recurring expenditure towards training to Medical Officers, Staff Nurse, Pharmacist, Lab Technicians and Ministerial Staff from project hospitals and Urban Primary Health Centres from project cities.

- ii. The Project Director, Tamil Nadu Urban Healthcare Project is permitted to transfer Rs.3,34,98,000/- (Rupees Three crore thirty four lakh and ninety eight thousand only) to the Director General of Training, Anna Institute of Management towards Hospital Management Training including TA/DA cost and to get the vouchers from the Institute for reimbursement as detailed below:-
